# **PROFESSIONAL**

Mr. Binns is a Philadelphia lawyer who specializes in litigation. Mr. Binns has been rated AV Preeminent for the past 50 years by Martindale-Hubble, the world's most trusted legal Peer Review Rating process. He is acknowledged to be among the top 5% of Pennsylvania attorneys and as a Super Lawyer by his peers at the Philadelphia Bar. Since 1965 his areas of practice have included White Collar criminal cases, Complex and Multi-District litigation involving claims of Securities Fraud, Price-Fixing, Mass Torts, Legal Malpractice, Personal Injury, Medical Malpractice, Ponzi Schemes, Sports related issues and Family Law. Mr. Binns enjoys an international reputation for handling high profile cases with an emphasis on jury trials. He has served as lead and co-lead counsel in a number of nationwide class actions involving claims of Securities Fraud and Price-Fixing. His Criminal Law practice includes a number of trials to verdict as well as counseling individuals subpoenaed to testify before state and federal Grand Juries. In 1971 he successfully brought a class action in the USDC for the EDPA to rescind a sixteen million dollar (\$16,000,000.00) insurance policy issued by Lloyds of London to the Penn Central Company. That lawsuit (Bird v. Penn Central) resulted in a landmark decision governing the law applicable to Directors and Officers liability insurance which remains viable law throughout the insurance industry. In 1978 he brought an anti-trust suit in the USDC for the EDPA on behalf of the Philadelphia Eagles against banks who were accused of freezing them out from financing. In 1980 he defended United States Congressman Raymond Lederer in the FBI "ABSCAM" prosecution which was brought by the DOJ in the USDC for the EDNY. During that same year (1980) he was designated lead counsel in a class action which he brought in the USDC for the EDPA against the Sun Oil Company. He successfully resolved that lawsuit the following year. In 1981 he won the "Indy 500" representing Penske Racing and three time champion race car driver Bobby Unser. During that same year (1981) he won 51 consecutive acquittals in state court for members of the Philadelphia Federation of Teachers ("PFT") who were charged with engaging in criminal conduct during the longest organized labor strike in the history of the City of Philadelphia. In 1984 he represented a defendant in a multi-defendant indictment which was brought by the DOJ in the USDC for the EDPA charging all of the defendants with engaging in a RICO Conspiracy to distribute controlled substances. US v. George Martorano, et al., 866 F.2d 62 (3rd Cir. 1989). In 1991 he successfully defended the World Boxing Association in a fifty million dollar (\$50,000,000.00) claim brought by Heavyweight Champion Mike Tyson in the USDC for the SDNY. In 1998 he defended Don King Productions ("DKP") in a one hundred million dollar (\$100,000,000.00) lawsuit brought by Heavyweight Champion Mike Tyson in the USDC for the SDNY. In 2005 he defended Imam Shamsud-Din Ali in a major Political Corruption trial as the result of a RICO indictment brought by the DOJ in the USDC for the EDPA.

In 2014 Mr. Binns won a four million, seven hundred forty two thousand dollar (\$4,742,000.00) jury verdict in the USDC for the EDPA in a Wrongful Death action which he brought on behalf of a family whose son was shot and killed by a police officer. In 2015 he settled an eight million dollar (\$8,000,000.00) state court Wrongful Death lawsuit on behalf of a family whose children were the victims of a school bus accident. In the same year (2015), he successfully defended an eighteen million dollar (\$18,000,000.00) "claw-back" lawsuit brought in the USDC for the EDPA by the Receiver of a Ponzi scheme. In May of 2015, after a 7 week jury trial, he won an acquittal for a Philadelphia Narcotics Police Officer who was indicted by the DOJ in the USDC for the EDPA for allegedly engaging in a RICO conspiracy. In 2016 he achieved a thirteen million (\$13,000,000.00) settlement of a Wrongful Death lawsuit on behalf of the family of a Police Officer who was killed in the line of duty.

During his six decade career at the bar, Mr. Binns was accused of being ineffective only one time, viz., by a convicted felon and his lawyer, Samual C. Stretton. In addition to finding that "....Mr. Gates has failed to comply with my sequestration order....", the United States Magistrate Judge analyzed the accusation and dismissed it finding that Mr. Binns's trial tactics, criticized by the felon and Mr. Stretton, was "....good lawyering,..." as per the attached **ORDER.** 

As part of his commitment to the legal process Mr. Binns has chaired the Judicial Selection Commission of the Philadelphia Bar Association and chaired a Hearing Committee of the Disciplinary Board of the Supreme Court of Pennsylvania. He has repeatedly been named by the Chief Judge of the United States District Court as a Delegate to the Third Circuit Judicial Conference. He was appointed by the Chief Judge of the Third Circuit Court of Appeals to serve as a member of the Lawyers Advisory Committee (2002 – 2004). He is a member of the American Bar Association and National Association of Criminal Defense Lawyers.

Mr. Binns serves as an expert witness in legal malpractice cases. #### **ORDER**

Petitioner Victor Gates has filed a motion for permission to present additional witnesses in support of his motion to vacate his sentence under 28 U.S.C. 2255. Doc. No. 180. The motion includes an Exhibit "B" listing nineteen witnesses that Mr. Gates would like to call. Doc. No. 180-2. The government has filed a response requesting that the motion be denied in its entirety. My review of the motion and the accompanying attachments reveals that:

- Mr. Gates has failed to provide affidavits of any witness that establishes that the witness will testify to information that relates to the relevant issue of ineffective assistance of counsel and will be helpful to me as the trier of fact.
- With respect to Mr. Philip Cochetti, Mr. Gates has failed to comply with my sequestration order, and has provided an affidavit that attempts to respond to the testimony of James Binns, Esq. Nevertheless, this affidavit contains much that is irrelevant and little that is probative about the dispute before me, which is whether trial counsel was ineffective. The Cochetti affidavit seems to be devoted primarily to explaining why Mr. Cochetti's theory of defense for Mr. Gates would have been better than Mr. Binns'. I read the affidavit, and counsel's lengthy memorandum, with great

care. I came away profoundly unconvinced by Mr. Cochetti's thesis. I am satisfied that putting Mr. Cochetti on the stand at trial to testify in accordance with his affidavit would have been utterly disastrous for Mr. Gates. I find that Mr. Binns' decision not to put Mr. Cochetti and his alternate defense theory on the stand at trial was good lawyering, and did not prejudice Mr. Gates. I do not need to hear Mr. Cochetti reiterate the content of his affidavit via live testimony.

Therefore, it is on this 10<sup>th</sup> day of August, 2021, **ORDERED**, that the motion for permission to present additional witnesses in support of his motion to vacate is **DENIED** as to all witnesses, except Mr. Gates. Mr. Gates may testify at an evidentiary hearing on the **6**<sup>th</sup> day of **October**, **2021**, from 9:30 a.m. to 12:00 p.m. in **Courtroom 3D.**
